By lunchtime on the Saturday some fifteen works had already been sold, although the purchasers were not allowed to remove the works until after the show was over.



PARISH COUNCIL NEWS

Stansted Airport Appeal Lost.

It is probably no great surprise to most people that we lost the appeal. It is still a big disappointment. The government have chosen to overlook the noise, health pollution, community cohesion, environmental and air quality concerns in favour of now outdated government policies and dubious economics. The genuine concerns of local people counted for little in the government's views.

Some of the costs have been awarded against Uttlesford District and Essex County Council, quite how much will be a subject of much argument in the months to come.

This must only strengthen our resolve to defeat the Runway 2 propositions. Although the appeal has been upheld, there were many things in the inspector's report which give an element of hope that Runway 2 could be, for this area, a runway too far.

Nowhere is safe from the threat of development

We have heard a great deal about Eco Towns and the prospect of yet more houses to be built in the south east, and it would be unwise to assume that despite the Rochfords Estate, that there is unlikely to be any more new housing in Birchanger in the next ten years.

The government has set high targets to identify sites in and around settlements for potential housing developments. This might provide a landowner's bonanza as they scramble to have their particular field or garden on the edge of a settlement considered. Listing a potential development plot would not necessarily mean that the site would be developed. There will be other criteria to consider.

Birchanger will feature on any potential list as it ranks fairly high in the sustainability ratings by

having a school and transport links. No more than 50 houses would be envisaged in any one location and the smallest development would be 6 houses. It would be very surprising if a development of 50 houses would be approved in a village situation.

The type of housing would be based on a Housing Needs Survey which is currently being undertaken. Birchanger has many young families who are desperate to have their own home in Birchanger and with the average house price in the Uttlesford District being at £298,625 higher than the average for the rest of Essex at £229,165, buying is not an option for most. The requirements are that for market housing sites for over 15 new houses at least 40% must be affordable. Developers do everything they can to avoid providing this type of less profitable housing and suddenly it seems that there are a great many proposals submitted for developments of 12-14 houses. Affordable housing is usually provided by a Registered Social Landlord who works closely with the District Council. Affordable units should not be placed necessarily in one area, but spread throughout the development. The exceptions are special small housing schemes commissioned by the Rural Housing Trust, such as those in Newport which are built on greenfield land and are 100% affordable. All affordable units should be for rental only. and remain so in perpetuity. It is the right to buy which has led to the shortage of affordable homes throughout the country, as Housing Associations have not been able to keep up with the demand. Councils, despite their close connections with Housing Associations, have not been allowed to build homes for rental in recent years. The shared ownership schemes have not proved to be attractive and in the current climate are mostly no longer affordable. Realistically it is unlikely that there would be another Rochfords in Birchanger. The many young people on the waiting list for a home in

the village would tell you that there is a very real need for a small number of homes for really local families. This is something which whatever happens with the Elsenham development, will need to be considered in the months ahead.

Runway 2 Inquiry update

Birchanger Parish Council is a registered participant to the Inquiry into Runway 2 which is still scheduled to start on April 15th. It is not yet known whether the government will expect the District Council to fund the costs of the inquiry. Apparently government expects District Councils to fund the costs of inquiries in their patches, something which seriously disadvantages the smaller District Councils such as Uttlesford. It could even be said to be discriminatory and to prohibit the rights of smaller communities to appeal on any major planning application. Surely BAA would be expected to bear some of the costs? It was their idea after all!

The pre inquiry meeting at which Birchanger Parish Council will also be represented takes place at 10.30 am at the Hilton Hotel on Monday November 10^{th.}

The good news is that as the inquiry could run for up to 18 months, so it is very unlikely that this government will be making the final decision.

"Burns Night" is back by popular request

Last January SSE hosted a groundbreaking Burns Night in the Church Hall. Those who were fortunate to attend enjoyed a traditional Burns Night Supper complete with pipes, drums and an accordion, all staged in the very best Scottish Style.

Many were disappointed as the tickets were strictly limited to 96, to match the capacity of the Church Hall. Nothing can be done about the size of the Church Hall but you can act fast to ensure a ticket for the next Burns Night which will be on Saturday January 31st in the Church Hall.

Tickets are on sale now and available from Elizabeth Godwin on 812793, Alex Stuart on 812303, Brian Ross on 814961, or the SSE office on 870558. This year the ticket price of

£22.50 per person includes a free bottle of red and white wine as well as a half bottle of whisky per table of 8. Additional wine will be available to purchase and glasses will be provided so there is no need to bring your own this time! You can also purchase as few or as many tickets as you like, but you will have to act soon to avoid disappointment.

Is this really a good new deal for those on incapacity benefits?

We are becoming increasingly uneasy about those in Government who seem to think that they know what is best for us. Is it really best for us when lifesaving drugs are withheld? Is it really good to allow fuel prices to go through the roof to the point where they have a serious impact on the most vulnerable in our society? Will it really be good for us to work when they are ill, something my doctor is constantly telling me that I should not do?

The government has now decided that there is a body of evidence to show that people are better off in work, not only through their pockets but also through their enhanced self esteem, seemingly irrespective of the job they are doing and the conditions in which they have to do it. They think that everyone should have the opportunity to work, agreed, but that those with an illness or incapacity should get the support they need to engage in appropriate work if they are able. I wonder how this concept will sit with a small employer when the employee rings to tell them they are not feeling too good today so will not actually be turning up until they feel better, whenever that might be.

The new allowance which will start from October 27th is called the Employment and Support Allowance, initially for new customers only. There will be personalised support for those suffering from a disability, imagine a friendly Employment Officer and an apparently vague number of other services. For those not suffering from a disability allowances appropriate to their needs will be paid while they look for employment. They will also be expected to attend regular meetings with their "Personal Advisor". Sounds like a rehash of the old mix somehow.

Our new nursery building

As little as six months ago, our nursery, which is a registered charity, was in danger of having to close its doors for good unless we were re-housed. The old building had seen better days and was past the point of repair. The staff, parents and board of trustees were determined to save the much loved local facility and so set about finding out what could be done.

Valiant efforts were made by parents and staff at fund raising, but it quickly became obvious that we needed significant outside help to reach the £170,000 needed to clear the site and erect a replacement building. In the end it was a joint application from Birchanger Nursery Unit and Essex County Council's Early Years and Childcare services that was successful in being awarded a Capital Building Works grant from Sure Start, and building work started as soon as the summer holidays started. The whole project had to be completed within six weeks, to be ready for the children to start the new term in September.

Our grand opening on Wednesday 1st October 2008, with guest of honour "Elmer the Elephant" was a celebration of this outstanding achievement. The nursery, which is based in the grounds of Birchanger primary school, is an extremely well regarded facility, popular with families from Bishop's Stortford, Stansted and surrounding villages. We achieved an excellent Ofsted report earlier this year and the new building has meant that all the hard work put in by the nursery's staff in striving for accreditation through the Pre-School Learning alliance has not been in vain.

We would like to extend our sincere thanks to everyone who has been involved in this project. We now have a fantastic new nursery building which will provide a safe, stimulating environment for local children for many years to come.
