## 1299. Minutes of the last meeting

## 1300. Land between Stansted and Birchanger

A consortium called City and Country (C&C) had circulated a leaflet in which they proposed developing a considerable area of Green Belt land between Stansted and Birchanger with the aim of building a substantial number of houses. PS, AD and GD had attended a drop in organised by City and Country to present their plans.

AD, GD and ST attended a meeting with Stansted Mountfitchet Parish Council and C&C. No assessments have yet been carried out and the sites identified had previously been submitted for planning under the Local Plan Call for Sites and all refused by UDC. City and Country hoped to have some of the land re-designated from Green Belt to Grey which, they hoped, would make planning permission more likely. Their intention is to produce actual plans and meet with the two parish councils some time next year.
