## 1285. Minutes of the last meeting

The minutes of the last meeting held on Tuesday 1<sup>st</sup> October 2024 had been previously circulated. A small amendment was made to 1272 ("cyclists" changed to "cycles") which was initialled by the Chair. The minutes were then agreed as a true and accurate record and were duly signed by the Chair.

## 1286. Offer of land to Parish Council

A meeting was arranged with the owner of the land, attended by AD, ST, GT and KW. The landowner is suggesting that the Parish Council may wish to build a village hall or similar structure on the small parcel of land which he is prepared to donate. The Chair pointed out that the Village already had a Village Hall and that the land on offer was within Green Belt. The Parish Council is strongly opposed to any building on Green Belt land. The Chair thanked the landowner for the offer and said that in view of the Council's comments the Council would decline the offer. The landowner thanked the Council for the opportunity to discuss his proposal and the meeting was terminated.

## 1287. Planning

## UTT/24/2440/HHF-99 Birchanger Lane

Erection of garage

Birchanger Parish Council comments

This application is a retrospective submission.

Work has been undertaken after the initial approval of UTT/18/2403/HHF, granted in October 2018, expired. Such works include footings for a double garage and the construction of a 2m high visually intrusive brick wall along the front boundary. The wall height was not determined in the initial planning application but was identified as "lower brick boundary wall". In effect, lower than the hedge that it replaced. It isn't! The wall is too high.

It is not clear if the proposed replacement hedging remains part of the latest application. It would be unlikely to grow between the structures and any maintenance would be a challenge.

The other significant change is the intention to build a double garage. The previous application identified a pitched roof cart lodge. The cart lodge roof eaves were to be lower and were intended to "not change greatly the public perspective of the setting..." (UTT/18/2403/HHF statement). This is no longer the case. The proposed full height double garage structure will be out of character with the other properties in that part of Birchanger Lane. It will also restrict vision of drivers travelling north, downhill through the village approaching the High View, Birchanger Lane junction.

The combination of the boundary wall and garage construction will clearly restrict visual acuity along that section of Birchanger Lane (hill and bend) potentially reducing splay lines for both pedestrians and car users travelling in both directions. It is necessary for pedestrians to cross the road in this section as the public footpath ends and transfers to the other side of the road.

Whilst it is noted that the LPA does not have specific policies regarding the positioning of garages, in this case it is detrimental to the street scene, out of character, and poses an enhanced risk to the users of Birchanger Lane.

Birchanger Parish Council objects to the UTT/24/2440/HHF planning application.

### 1288. Exit from Birchwood

A resident has highlighted that there is a sign just after the Village Hall directing traffic to Birchwood along a lane behind houses fronting Birchanger Lane. This road here is narrow with no pedestrian walkway. As traffic can go in both directions this is a potential safety hazard. There is a turning just before the Club which takes traffic to Birchwood from Birchanger Lane. The resident has suggested that traffic exiting Birchwood be left turn only past the Club to get to Birchanger Lane. The misleading sign just after the Village Hall should be removed. RG has already applied for LHP consideration and advises that this is up for discussion in January 2025.

## **1289.** Dog Bins

As the bin on the sand track seems to fill very quickly GD has suggested the purchase of a second bin for this site. The clerk will obtain prices.
